STAFFORD DIRECT STUDENT LOANS (SUBSIDIZED AND UNSUBSIDIZED)

- You must be enrolled a minimum of 6 credit hours during the Summer term.
- Receipt of Stafford Direct Loans in Summer will decrease the amount available during the subsequent Fall/Spring semesters. Federal Regulations allow an annual 12 month maximum combined loan limit depending on your year in college. Loan limits are as follows:
 - Freshmen (0-29.99 earned credits) \$5,500 (up to \$3500 subsidized)
 - Sophomore (30-59.99 earned credits) \$6,500 (up to \$4500 subsidized)
 - Bachelor Degree seeking students with at least 60 earned credits (Junior & Senior) \$7,500 (up to \$5500 subsidized)

FEDERAL COLLEGE WORK STUDY

- You must be enrolled in a minimum of 6 credit hours during the Summer term.
- You must be registered for a minimum of 6 credit hours for the Fall 2017 term.
- Limited positions. Please check on website for available positions after May 1st.
- Summer assignments will run July 5th through August 16th.
- Students are limited to 20 hours per week.
