I understand and agree that this Agreement and Release of Claims covers all known, unknown, or unforeseen claims and the consequences thereof, notwithstanding the provisions of any law or ordinance to the contrary (including any claims covered by applicable Workers' Compensation laws), and I specifically waive any rights accruing thereunder.

I agree for myself and my heirs, executors, administrators, legal representatives, successors and assigns that if any claim for personal injury, death, or property damage is prosecuted against Released Parties as a direct or indirect result of my activities or participation in the Program (other than any claims covered by applicable Workers' Compensation laws), I shall indemnify and save harmless Released Parties from all such claims, causes of action or damages, including attorneys' fees, by whomever made and wherever presented.

I understand I will have to pass the National Grid Pre-Entry Physical Assessment prior to acceptance in the Program and I will have to perform physical tasks as part of the required Program curriculum. Physical tasks include but are not limited to performing excavation / backfilling and the use of various pneumatic / hand tools including jackhammers and rotary drills, etc. I understand and agree that prior to participating in the Program and prior to signing this Agreement and Release of Claims, I have consulted my health care provider about any potential risks associated with my participation in the Program.

I further state that there is no medical condition which I am aware of or should be aware of that, with or without reasonable accommodations, would prevent me from participating in the Program.
