Who Must File a Return?

Whether you must file a return depends on your ***gross income, filing status, and age***.

Gross Income

Gross income includes all income that you receive in the form of money, goods, property, and services. It does not include any income that is tax-exempt.

Filing Status

Your filing status is determined on the last day of the tax year, which is December 31 for calendar year taxpayers. Your filing status will be determined by whether you are single or married, and what your family situation is.

Age

If you are age 65 or older on the last day of the tax year, you are allowed a higher amount of gross income before you are required to file a return. The table below lists the income limit amounts for the 2024 tax year.

Single	under 65	\$14,600
	65 or older	\$16,550
Married Filing Jointly***	under 65 (both spouses)	\$29,200
	65 or older (one spouse)	\$30,750
	65 or older (both spouses)	\$32,300
Married Filing Separately	any age	\$5.00
Head of Household	under 65	\$21,900
	65 or older	\$23,850
Qualifying Widow(er) with Dependent Child	under 65	\$29,200
	65 or older	\$30,750

* If you turn 65 on January 1, 2025, you are considered to be age 65 at the end of 2024.

** Gross income means all income you received in the form of money, goods, property, and services that is not exempt from tax, including any income from sources outside the United States (even if you may exclude part or all of it). Do not include Social Security benefits unless you are married filing a separate return and you lived with your spouse at any time during 2024.

*** If you did not live with your spouse at the end of 2024 (or on the date your spouse died) and your gross income was at least \$5.00, you must file a return regardless of your age.
