COST EXPLANATION

Application Fee – paid by the student at the time of application

****Tuition and Fees** – SUNY students pay tuition and fees at their home campus. Mandatory college fee varies per institution. The tuition and fees are estimates. SUNY tuition and fees are subject to change without notice by action of the SUNY Board of Trustees. The cost listed here is based upon 3 credits (FSC).

*****Overseas Academic Program Differential** – The overseas partner charges FSC for the tuition, college fees, and housing of visiting students. If the partner school costs are higher than the SUNY tuition, the student is billed the difference to cover the full program cost. This differential is based upon housing costs and the tuition rates of FUA.

FSC Overseas Academic Program Fee – This fee covers the administrative and operational costs of this program.

Health and Medevac Insurance – All study abroad participants are required to purchase the SUNY mandated health insurance policy. This policy includes evacuation, repatriation and traveler assistance coverage. (This is not Travelers insurance).

Projected Expenses – These are estimated fees and vary due to exchange rate fluctuations and personal spending habits. Some courses have a lab component, lab fees are billed separately by the host institution upon arrival.

FUA-AUF's CANCELLATION POLICY:

Tuition:

30-7 days before arrival, 50% refund

Less than 7 days before arrival (or during session), 0% refund

Housing:

Less than 40 days before arrival, 0% refund
